The City of Capitola began issuing photo red-light citations since November 1, 2005. Photo Red light reconciliations occur every six months beginning at the start of Capitola's fiscal year (July 1). The reconciliation reconciles revenue received from Santa Cruz Superior Court for Photo Red light Citations. The most recent reconciliation occurred at the end of the first half of FY 11-12 (July 1, 2011 through December 31, 2011) for the amount of \$47,190.01. I have received from Renee Harrison the total for FY 11-12, amount received for red light fines, including delinquent collections, which is \$104,120,81. The amount of \$104,120.81 is derived from adding the total in column "To Cap GF" (\$42,560.47) with the total in column "Red Light Traffic School" (\$59,580.33) plus "Delinquent Collections" (\$1,980.01).

I recommend remitting to ATS the amount of \$49,865,28, which is the total County collections of \$104,120.81 for FY 11-12, deducting the first half FY 11-12 payment of \$47,190.01, and actual court time costs of 88 hours (\$7,065.52) of Sgt. Eller's court time adjudicating photo red light citations, total for FY 11-12. This is in compliance of our contract. The amount is below the \$125,940 billing from ATS for twelve months of service or \$10, 495.00 per month.
