Your Honor:

On January 11, 2012, we requested the dismissal of 163 citations due to a yellow light timing anomaly at the intersection of Arden Way and Watt Avenue. The yellow time was indicating 3.54–3.56 seconds for all five enforced lanes at that intersection on the captured red light violation images. This is the correct yellow time for lanes #1 and #2, which are left turn lanes, but not correct for lanes #3, 4 and 5, which are straight and right turn lanes. Based on speed surveys, Sacramento County Department of Transportation (DOT) has historically set lanes 3, 4 and 5 of this intersection at 4.8 seconds of yellow time.

After this request was made, we discovered that our vendor, Redflex, provided an erroneous report of the red light times for all the violations that occurred during the period of July 15, 2011 to December 23, 2012. A follow-up, accurate report revealed that there are 90 additional violations with a red light time of 1.26 seconds or less, which was the missing yellow light time during this period of time.

Due to this discovery, we are convinced of the factual innocence of these additional defendants who have been convicted based on evidence we thought to be true, but now know was in error. In order to avoid a miscarriage of justice, we ask that the court dismiss the additional cases listed on the attached document.
