RECOMMENDATION

Approve Amendment No. 1 to the agreement with Redflex Traffic Systems Inc., to extend the term of the agreement for one additional 2-year term and amend compensation and pricing; and authorize the City Manager to execute the Amendment.

BACKGROUND

The City of San Matec has contracted for red light traffic enforcement services with Redflex since May of 2004. The current agreement for services was approved by the City Council in November 2009 for a six (6) year term and will expire later this month; however the agreement provides an option to extend the term for up to two (2) additional consecutive two-year periods.

The city pays a fixed monthly fee of \$4,980 per intersection approach. There are currently five intersection approaches in San Mateo outfitted with red light cameras. Staff is not recommending adding any additional approaches. As part of the amended agreement, Redflex will upgrade some components of the existing equipment. In addition, staff has negotiated the terms of compensation and pricing to reduce the fixed monthly fee per intersection approach to \$3.985, resulting in an annual savings of \$59,700.

The red light photo program is a valuable component of our comprehensive approach to reduce injury collisions and enhance pedestrian and traffic safety throughout San Mateo, and staff recommends exercising the option to extend the contract for one additional 2-year term, through November 2017.

BUDGET IMPACT

Funding for this agreement has been allocated in the Police Department's FY15/16 operating budget in 10-5112-07-5311. The amendment will result in an estimated annual savings of \$59,700.

8. Automated Traffic Enforcement System - Amendment

Police Chief Susan Manheimer presented an alternative action to adopt a 90-day extension to the agreement with Redflex to allow staff time to respond to the issues raised from the public. The Council asked questions of staff.

Public Comment: Bob Berger stated because cameras are unpopular is not a reason to discontinue them; fines are ridiculously excessive and it is not proven that there was a pedestrian safety issue at the intersections with red light cameras. Andre Clemente spoke on behalf of several people in the audience, asked why cameras are needed in this intersection, more right turn tickets are issued, and asked if this is a cost effective use of the tax dollars.

Council Comments:

Council Member Lim noted there were some good questions raised about the red light camera operations which should be investigated; however he stated his support for the red light camera enforcement and noted that California right turn rolling stops are illegal and the camera enforcement helps change behavior.

Council Member Bonilla stated his support of the 90-day extension to do further investigation on the questions raised and highlighted one comment received that there are economic consequences to the high ticket prices.

Council Member Goethals stated the City's Vision Zero calls for no traffic fatalities at all; with that in mind enforcement should be focused on safety first, not revenue.

Deputy Mayor Matthews stated he agrees with the focus on safety and noted the City used to employ ten traffic cops and now only has four with the result that we rely on red light cameras to do their job, as the police cannot be there to monitor. He noted the need to be judicious in how they are used and the need to be effective in making the intersections safer.

Mayor Freschet agreed the issue is a safety issue and it is a good recommendation to extend for 90 days to study more comprehensively.

Motion by Matthews, second by Bonilla, to Approve a 90-day extension to the agreement with Redflex Traffic Systems Inc.; and authorize the Mayor to execute the extension. The motion carried by the following vote:

RECOMMENDATION

Approve Amendment No. 2 to extend the Term of the agreement with Redflex Traffic Systems Inc., for 90 days to commence February 15, 2016 and end on May 16, 2016; and authorize the City Manager to execute the Amendment.

BACKGROUND

The City of San Mateo has contracted for automated traffic enforcement services with Redflex since May of 2004. The most recent agreement for services was approved by the City Council in November 2009 and was to expire in November 2015. On November 16, 2015, the City Council adopted a 90-day extension to the agreement with Redflex to allow staff time to respond to issues and address concerns raised by the public.

Staff is working to prepare a detailed presentation on the automated traffic enforcement program. Statistics and program data from the 2015 calendar year are not yet available. An additional 90 day contract extension is requested to allow for preparation of a more comprehensive review and analysis of the program which can incorporate final data from the most recent calendar year.

Funding for this agreement has been allocated in the Police Department's FY15/16 operating budget in 10-5112-07-5311.

AMENDMENT NO. 2 TO THE AGREEMENT BETWEEN THE CITY OF SAN MATEO AND REDFLEX TRAFFIC SYSTEMS, INC. FOR RED LIGHT TRAFFIC ENFORCEMENT SERVICES

WHEREAS, the City of San Mateo ("CITY"), a municipal corporation of the State of California, and REDFLEX TRAFFIC SYSTEMS, INC. ("REDFLEX"), 23751 N. 23rd Avenue, Suite 150, Phoenix, AZ 85085, entered into an Agreement on November 18, 2009; and

WHEREAS, CITY and REDFLEX wish to amend the Agreement to extend the term.

NOW, THEREFORE, the parties agree as follows:

- 1. The parties agree to extend the Agreement for an additional ninety (90) days to commence on February 15, 2016 and end on May 16, 2016.
- 4. All other terms of the Agreement and any subsequent amendments remain in full force and effect.

PUBLIC HEARING

10. Downtown Parking Permit Changes

Assistant City Manager Matt Bronson reported on the proposed parking permit rate structure, including finalizing online purchase system and conducting user testing work with Downtown San Mateo Association (DSMA) and Downtown businesses to communicate changes and answer questions. The plan is to sell new monthly permits beginning in July in order to provide sufficient lead time.

Staff responded to questions from Council who expressed interest in: providing reduced parking fees for those non-profits providing services for San Mateo in the Downtown; working with Public Works on better lighting and necessary tree trimming on the walkways between Kinko's lot and the Workers Resource Center; building in specifications for a new option to add to current time and mobile payment options to parking meters; the ability to register more than one plate per permit; and the ability to monitor parking trends over time without having to commission a separate study.
